

ALL-STAR REQUIREMENTS

1. Be 15 years old by January 1st of the current year.
2. Must have a Gold Star.
3. Must turn in a 4-H Record Book on the National Report form and submit to a personal interview.
4. Should plan to attend the State All-Star and Leadership Conference.
5. Will be enrolling as a 4-H member next year.
6. Has demonstrated leadership abilities, citizenship concern and maturity of judgement. (i.e.: LCORT, Citizenship Focus, camp, Jr./Teen Leader committee and/or weekend, 4-H building, etc.)
7. Has made a significant contribution to the maintenance and expansion (outreach) of the 4-H Program.
8. Must have ideas for an action plan for leadership in the 4-H program within the county.
9. Give a report to County Council after selection and at the annual meeting. Introduce yourself and report on your plans and activities as an All-Star.

AREAS OF RESPONSIBILITY

As part of the All-Star Team:

1. Plan the Junior/Teen Leader Weekend.
2. Plan the County Demonstration Day and Regional Demonstration Day, if applicable.
3. Plan Awards Ceremony.
4. Implement an action plan, individually or as a group.

OTHER AREAS ALL-STARS CAN WORK IN:

1. Install Club Officers when asked by a Club.
2. Conduct Club Training when asked.
3. Provide Leadership in the Community Service Area for the County Leadership Project.
4. Be a youth delegate to the regional meeting.
5. Visit 4-H Community Club meetings.
6. Give presentations about All-Stars at county functions and whenever possible.

Being selected is the highest County honor that can be attained by a 4-H Member. The honor recognizes the achievements and potential of the member selected. Along with the recognition, there are responsibilities, which will require a commitment of time and support for the All-Star programs.
